RESOLUTION OF THE TOMS RIVER MUNICIPAL UTILITIES AUTHORITY COUNTY OF OCEAN, STATE OF NEW JERSEY, APPROVING \$379,800 FROM FY2020 BUDGET FOR CAPITAL EXPENDITURE RESERVE

WHEREAS, the Annual Budget and Capital Budget for the Toms River Municipal Utilities Authority (TRMUA) for the fiscal year beginning January 1, 2020 and ending December 31, 2020 contained certain budgeted expenditures for capital projects; and

WHEREAS, certain line items were not fully expended in FY2020 in the amount of \$300,000 for the Administrative heating and air conditioning and Administrative Building upgrades, \$48,500 of un-spent IT capital funds, \$7,500 for telephone system, \$6,000 for electric truck covers, \$10,000 for furnishings and \$7,800 for upgrade admin building security system; and

WHEREAS, the TRMUA staff has requested the total sum of \$379,800 be reserved from FY2020 for Capital Expenditures in the Capital Asset Reserve Account; and

WHEREAS, the Chief Financial Officer has determined that the reserve of funds will not have an adverse impact or materially alter the financial condition of the TRMUA.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE TOMS RIVER MUNICIPAL UTILITIES AUTHORITY, COUNTY OF OCEAN AND STATE OF NEW JERSEY, at an open public meeting held on January 26, 2021 that the sum of \$300,000 for the Administrative heating and air conditioning and Administrative Building upgrades, \$48,500 of un-spent IT capital funds, \$7,500 for telephone system, \$6,000 for electric truck covers, \$10,000 for furnishings and \$7,800 for upgrade admin building security system from FY Budget 2020 totaling \$379,800 is hereby reserved for Capital Expenditures in the Capital Asset Reserve Account.
