WHEREAS, said proposal has been reviewed by the Authority's Director of IT and he is satisfied with the terms, conditions and cost of the proposal; and

WHEREAS, this service is exempted from public bidding pursuant to 40A:11-5 (f) of the Local Public Contracts Law; and

WHEREAS, this proposal is awarded for a period not to exceed thirty six (36) months pursuant to 40A:11-15 (8) of the Local Public Contracts Law.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE TOMS RIVER MUNICIPAL UTILITIES AUTHORITY, COUNTY OF OCEAN AND STATE OF NEW JERSEY, as follows:

- 1. That the Board of Commissioners of the Toms River Municipal Utilities Authority does hereby award a contract to Comcast to provide Fiber Optics for the Authority's Internet Data Speed Network for a period of thirty six (36) months at a cost of \$800.00 per month, plus a Ethernet Standard Installation Fee of \$500.00.
- 2. That funding for this contract is available in the 2018 operating budget under line item 106-6101.
- 3. That award of this contract is contingent upon adequate funding in the 2019 and 2020 operating budgets.
- 4. That the Executive Director is authorized to execute and the Assistant Secretary to attest to the proposed form of contract, which shall be available for public examination in the office of the Assistant Secretary during normal business hours.
- 5. That the Assistant Secretary shall further forward a certified copy of this resolution to Comcast, the Chief Financial Officer, the Director of IT and the QPA.
