TO Vortex Services, LLC

WHEREAS, the Toms River Municipal Utilities Authority (hereinafter "TRMUA"), County of Ocean, State of New Jersey advertised for bids in accordance with Local Public Contracts Law N.J.S.A. 40A:11-1 et seq. for Sewer and Manhole Rehabilitations (Cured-In-Place Lining) Contract SR-01-20, in accordance with plans and specifications prepared by the TRMUA Authority Engineer; and

WHEREAS, the TRMUA Commissioners reviewed the certification of available funds and recommendations made by the TRMUA Authority Engineer and TRMUA Attorney on said bid; and
