- 3. All non-aligned TRMUA employees, not covered by a separate agreement, shall receive a 3.5% increase over their 2024 salary effective January 1, 2025.
- 4. All non-aligned TRMUA employees, not covered by a separate agreement, shall be eligible to receive an in-house reimbursement maximum of \$2,000/year.
- 5. A certified copy of this resolution shall be forwarded to the Executive Director.
